

# 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

	Visually inspected with the aid of binoculars where appropriate.

Main Walls	The main walls are of solid stone construction. There is a provision of sub- floor ventilation.
	The extension walls are of cavity construction with an inner load bearing leaf of timber framing and an outer leaf of rendered concrete blockwork. The basecourse is finished in a smooth render and incorporates sub-floor ventilation.
	Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

Windows, External Doors and Joinery	The windows are of a mixed uPVC and timber casement sealed unit, double glazed type. There is a single glazed stained glass timber casement window at the half landing and a single glazed, timber sash and casement window within the larder cupboard.
	The front entrance door is of a composite and glazed manufacture whilst the rear doors are of a uPVC and glazed type.
	Roofline soffits and fascia boards are formed in timber.
	Internal and external doors were opened and closed where keys were available.
	Random windows were opened and closed where possible.
	Doors and windows were not forced open.

External Decorations	The external decorations are of a painted finish.
	Visually inspected.

Conservatories / Porches	The entrance porch is of a timber frame and stone wall construction contained under a sloping, lean to style, slate roof covering.
	The conservatory to the side of the property is of a rendered blockwork construction with timber casement, double glazed windows and contained under a shallow sloping clear polycarbonate roof covering. Visually inspected.

Garages and Permanent	There is a detached double garage of rendered blockwork construction
Outbuildings	contained under a pitched and tiled roof covering. The garage vehicular door is of a metal up and over type.
	Within the rear garden, there is a shed of timber manufacture with a pitched felt roof covering. Visually inspected.

Outside Areas and Boundaries	There is garden ground lying to the front, side and rear of the property. Garden areas to the rear are laid to grass and paving. There is a large lock block surfaced driveway to the front of the property which provides ample off-street parking provision.
	The boundaries are formed in stone walls, timber fencing and post and wire fencing, including a tree line at the rear. Visually inspected.

Ceilings	The ceilings are of mixed lath and plaster and plasterboard linings.

Internal Joinery and Kitchen Fittings	The internal joinery is of a painted softwood pattern comprising flush solid timber, timber panel and glazed timber doors.
	The staircase, balustrades and handrail are of timber manufacture.
	There is a modern fitted kitchen which includes both floor and wall mounted units, including a `Range Master` stove.
	Built-in cupboards were looked into but no stored items were moved.
	Kitchen units were visually inspected excluding appliances.

Chimney Breasts and Fireplaces	There are open fires within two of the first floor bedrooms which comprise cast iron/tiled surrounds. The fireplaces are not in use.
	There are open fireplaces within both the living room and dining room which comprise tiled surrounds and hearths.
	In addition, there is a gas fire installed at the fireplace within the hall which comprises a tiled surround and hearth.
	Visually inspected. No testing of the flues or fittings was carried out.

Internal Decorations	The internal decorations are papered and painted.
	Visually inspected.

Cellars	Not applicable.

Electricity	Mains electricity is connected.
	The electricity meter and consumer unit are located within the dining room cupboard press.
	Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Gas	Mains gas is connected.
	The gas meter is located externally within a service box to the side of the property
	Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Water, Plumbing and Bathroom Fittings	Water is from the mains supply. The plumbing installation where visible, comprises copper distribution pipes together with uPVC wastepipes. There are five modern white three piece en-suite shower room facilities which comprises mixer showers, wash hand basins and WCs.
	At ground floor level, there is a white three piece en-suite shower room which also comprises a mixer shower.
	There is a modern white four piece en-suite bathroom which comprises a bath, electric shower, wash hand basin and WC.
	Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.
	It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and Hot Water	There is a full gas fired central heating system which supplies a series of water filled radiators.
	Domestic hot water is provided by the `Worcester Greenstar` central heating boiler, together with an electric immersion heater fixed to the hot water tank, both of which are installed within the utility room.
	Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Drainage	Drainage is to the main public sewer.
	Drainage covers etc were not lifted.
	Neither drains nor drainage systems were tested.

Visually inspected. No tests whatsoever were carried out to the system or appliances.
New smake slarp standards were introduced in Sectland in February
New smoke alarm standards were introduced in Scotland in February
2022 and it is likely that some properties may require additional works
meet these standards. In instances where alarms are in place, no tests
whatsoever have been carried out and we cannot confirm if the system
complies with the most recent regulations. Any potential purchaser
should satisfy themselves as to whether the current system meets with
regulations or otherwise.



Additional limits to Inspection	The property was fully furnished at the time of our inspection and the
	services were not tested.
	No access was obtained to sub-floor areas.
	Not all windows and doors were tested at the time of inspection.
	Our inspection of the understair cupboard was restricted.
	Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only.
	No internal access was obtained into the garage due to the storage of contents.
	It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.
	No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.
	It should be appreciated that the Home Report inspection is a non- disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

Notes	Weathering was noted to the chimney stacks. It should appreciated that they are of an age where on-going maintenance will be required, particularly to flashing details to ensure water tightness.

Notes	It should be appreciated that flat roof coverings have a limited life only and require above average maintenance. Any information as to its last renewal date should be obtained, if available.
	The flat roof coverings over the bay windows are showing signs of weathering.
	Condensation staining was evident within the extension roof void area and there is a lack of roof void ventilation.
	Damage was evident to some of the decorative ridge tiles.
	The roof covering is now of an age where ongoing and regular maintenance will be required and it would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.

	Rainwater Fittings
Repair Category	2
Notes	Leaking was evident to the gutter at the side elevation. There is evidence of corrosion to sections of the cast iron fitments which could lead to leakage. Ongoing maintenance and repairs should be envisaged.

	Main Walls
Repair Category	2
Notes	The stonework is weathered and cracked in areas and attention is required to sections of pointing. Repairs in this regard should be envisaged as part of an ongoing maintenance programme. There is a missing extractor vent cover at the rear extension.

	Windows, External Doors and Joinery
Repair Category	2
Notes	There is a failed sealed unit to one of the skylight windows.
	Maintenance is required to the timber sash and casement window within the larder.
	The timber casement windows within the rear extension are of an older manufacture.
	Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.
	Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/ repair will be required as part of an ongoing maintenance programme.
	The external joinery is weathered at the side elevation and affected by timber decay.

Notes	The external decoration is weathered/decayed and an overhaul should be expected.

Notes	The ceilings are of lath and plaster construction and there is evidence of cracking and unevenness. Repairs should be anticipated. Some decorative surfaces are finished with an Artex type product. Early forms of Artex may incorporate small amounts of asbestos based bonding materials and therefore specialist advice should be obtained prior to working on these areas to minimise the risk of releasing hazardous fibres. Condensation staining was evident within a front bedroom en-suite shower room. Staining was evident at the extractor fan within the other front bedroom en-suite shower room, however, this was dry at the time of inspection.

Notes	Within the limits of our inspection these generally appeared in fair condition consistent with age. During redecoration some plaster filling/repair may be required.

Notes	Due to fitted carpets and floor coverings no detailed inspection was possible of the floor timbers and accordingly we cannot guarantee their soundness or otherwise. Areas of loose/uneven flooring were noted. There is evidence of woodworm, which we understand has been treated previously.

We understand that this has not been in use for some time and requires a replacement section of pipework prior to the fire being safely reused. # 4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

### Matters for a Solicitor or Licensed Conveyancer

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include changes to the internal configuration of the property, rear extension and the erection of both the conservatory and porch.

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

During the inspection it was observed that past timber/damp repairs have been carried out within the property and all specialist reports and guarantees should be obtained, studied and authenticated prior to purchase. If such reports cannot be obtained or do not exist then prior to purchase an inspection and report should be prepared on the whole property from a reputable firm of timber specialists so that any existing repair works or remedial works required are completed to a guaranteed standard.

There is a telegraph pole located within the garden of which we have assumed that any necessary rights of access are in existence.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

### Estimated Reinstatement Cost for Insurance Purposes



# The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. ## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

#### 1 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide longlasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

#### 2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

#### **3 Heating controls (room thermostat)**

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

#### 4 Replacement glazing units

Replacing existing double-glazed units with new high-performance units. Building regulations require that replacement glazing is to a standard no worse than previous; a building warrant is not required. Planning permission might be required for such work if a building is listed or within a conservation area so it is best to check with your local authority.

#### 5 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

### Low and zero carbon energy sources
